We are implementing a new payment system Rev Trak from Vanco.

Your student will have the opportunity to purchase al carte items in the lunch line, they can bring cash or you can sign up to add money to their account, they will use their school ID to purchase items. In addition to using Rev Trak to purchase items at lunch they and you will be able to purchase other items through this system such as dances, prom tickets, graduation packages, etc. More information about this payment system will be forwarded to you.

- **School Store**: City High has a school store where students may purchase items such as drinks, ice cream, etc. also using their school ID.
- Monthly Menus: Menus are emailed weekly to your student, and also posted on the website.
